6. President's Report for the year to September 2022

Events: Huge expansion in in-person events. Ball and Waitangi Day retrning. Fantastic job of doing events during Covid. Have had Jacinda Arden up and an event with Christopher Luxon at the High Commission. MAIA kicking back off again with events coming up soon. 5 a side, then 10 a side then full networking events have occurred. Several sustainability events including one with Grace Foo (Minister for Sustainability and Environment) and hosted by and held at ANZ.

More of these events will be coming up as it's a key pillar for the Chamber. Also hosted several personal development events – optimising your Linked In profile, navigating an inflationary environment, equipping learners.

International women's day event was a great success with fantastic women sharing their stories. Also held a whole range of virtual events including speed networking, the state of NZ property, virtual fundraisers etc.

7. Annual Statement of Accounts/Balance Sheet for the year to 31 March 2022

Stu O'Connor (Treasurer) presented the summary of accounts.

Over the course of the financial year the Board and management team continued to protect and optimise the financial position of the Chamber with a focus on cashflow management and ultimately sustaining the business through to a post covid world. Revenues from existing members and sponsorship further contracted. We did however see a lift in event income particularly in the last third of the financial year as restrictions slowly lifted. Reflective of a sustained covid environment, **we closed out the year with a loss of \$34k** but with momentum building into the next year.

The Annual Statement of Accounts were made available to members (2 weeks before the AGM) on the Chamber website.
